

"33" was commated this same year by Clara Reger, W2RUE, ex W8KYR — and adopted by Y1RL for ex Jusies YL use. It means "Love scaled with friendship between one YL and another Y1". With this background and meaning, it is very understandable that "33" is not only exclusive with YLs but is never used in the plural. We sign "33".

Minutes of ARLM Executive Meeting

The following are minutes of the ARLM Executive Meeting held at Neepawa, Sunday, October 5, 1980. The meeting opened at 13:00 CDT with the following present: N. Funge, 4CF, President; J. Brychka, 4 ADX, Northern Director; H. Fehr, 4AAF, Eastern Director; C. Attwood, 4NE, QSL Manager; T. English, 4TE, Observer; and J. Mercer, 4 ADD, Observer and Host.

Old Business:

The minutes of the previous Executive Meeting held in Winnipeg 19 March 30 had previously been mailed to all Directors. Three items arising from the minutes were discussed. With respect to the search for an editor to relieve John, 40L; a suggestion was made by Harold, 4AAF, that VE4ADJ, Joe, of Portage had expressed some interest. It was agreed that the President approach 4ADJ and discuss the job with him. Continuing concern exists about the lack of response in nominations for vacant Director positions, along with the recent departure of Steve, 4Al and Rolly, 4RS. It was resolved that a number of active hams from a list discussed at the current meeting, be approached with a view to obtaining sufficient nominations prior to the election.

Len, 4QL, being unable to attend due to illness, relayed that there was no outstanding correspondence. Thus, no information on the third item, the 1981 CARF Symposium, was available for discussion.

New Business:

Treasurer's Report:

Len, 4QL, although absent, passed on a statement on the financial situation. The present cash balance was \$2,260; of which \$2,000 was in a non-chequing interest bearing account; the rest remaining in the current (chequing) account. With the fall auction imminent, it was anticipated that an increase in revenue should accrue from the event.

ARLM Auction:

Noel, 4CF, reported that the annual ARLM fall auction would be held at the Red River Community College on Sunday, November 2nd, 1980. Mike, 4MP, has agreed to act as auctioneer once again. Some discussion ensured regarding ways to improve the administration of the auction.

MANAM Content:

John, 4ADX, suggested that more encouragement be given to members to submit newsworthy or short "hint and kink" type articles to improve the readability of the MANAM. He stated that Joe, 4AFM, of St. Rose was interested in making a contribution in this way, and discussion followed on other ways to give our publication a "face-lift".

Chris reported that approximately 300 requests come in to him annually for DX and US addresses.

There being no further business, the meeting adjourned at 15:00 CDT. Prior to adjournment, all members tendered a vote of thanks to our gracious hosts Jim, 4ADD and his charming XYL Minnie for their hospitality.

CARF NEWS SERVICE BULLETIN NUMBER 27, Sept 7/80

- Canadian and other Amateurs except U.S. operators will not be very happy to know that the American Radio Relay League directors have voted to ask the FCC to extend U.S. 40 and 20 metre phone privileges. They will request expansion for Extra class to have 14150 kilohertz and up; Advanced 14175 and up and General, all above 14225. On forty, they will request 7075-7100 kilohertz for Extra class phone as well, according to a recent HR Report.
- The British government has succumbed to pressure and is now prepared to permit a Citizen's Band on 900 megahertz. Optimistically it plans safeguards to prevent QRM to paging systems, radio-controlled models and other users from the expected 150,000 users. It's a sure bet that the British authorities have a lot to learn.
- In the meantime, back in Washington, the FCC has voted to ask for public comment on the petitions it has received to expand the CB band and to legalize the sliders and others operating illegally in the slot outside the present CB band.
- Returning to the domestic scene, the June exam results were disappointing compared with some of the previous ones. Of the 496 who wrote the Amateur ticket, only 80 got their certificates. It should be remembered, however, that many of those writing only tried one or two parts of the three-part test. On the theory part, out of 436 who wrote, 159 or 35% passed. Out of 322 who wrote the regulations part, 215 made it. On the code test out only 79 out of 227 made the grade. For the Advanced certificate only 49 out of the 219 who wrote all or part of the exam were issued their diplomas. Out of 144, 115 made the regs but only 47 cut of 108 read the code okay. Seventy-six out of 203 passed theory. The digital pictures was better...100% passed...that is, three out of the three writing the exam. Incidentally, U.S.sources quoting 300 digital operators in Canada are wide of the mark...according to DOC head office, it's more like one hundred. The exam success rate south of the border is different but for suspect reasons. The astronomical increase of 1,800 licensees in June alone is attributed to the sale of exact exam questions as "study material". U.S. Amateurs now number 385,625.

CARF NEWS SERVICE BULLETIN NUMBER 26

Here is good news for Canadian operators who vacation in Haiti. CARF has learned that Canada now has reciprocal operating privileges with that Caribbean country. Third party traffic arrangements are still under negotiation but should be concluded soon.

Watch for an FCC announcement proposing more sideband channels on the eleven metre Citizen Band, along with removal of the skip working ban plus the use of VFOs.

The DOC's two-way TV trial program being held in Manitoba in conjunction with that province's telephone system is under way with about one hundred homes hooked into the videotex or telidon equipment. The overall program has received a rude shock, however, with the announcement by Canadian telephone companies that they are withdrawing from further participation. The break reflects the escalating battle between cable TV interests and the telephone companies for the millions to be made in the future in this new area of telecommunications.

CARF NEWS SERVICE BULLETIN NUMBER 25

DOC has unveiled a plan for extensive public input to the preparation of Canada's position for post-WARC international conferences. Five major conferences at both regional and world-wide levels and comprising thirteen sessions will be held over the next few years. These meetings will seek to implement the frequency allocation agreements reached at Geneva last fall at the WARC'79 conference. The ongoing action will include bilateral negotiations with the U.S.A. The Department will seek to have five industry-government working groups organized to assist in framing the Canadian role in all of this post-WARC international bargaining. The ongoing work primarily affects industry but amateurs will be represented on those groups which may affect their assignments. This news was unveiled at the public briefing on the work of the Canadian WARC'79 delegation, held in Ottawa on June 18. Another major decision facing ITU is whether to set up a fourth Region which would take in all of Africa. CARF president Bill Wilson, VE3NR, DOC Liaison Committee head Art Stark, VE3ZS and Bud Punchard, VE3UD, the CARF WARC '79 Working Group chairman, attended as did Mitch Powell, VE3UT, ARRL Canadian director and Noel Eaton, VE3CJ, head of IARU. Special tribute was paid by DOC's Ed Ducharme, the meeting chairman, to the work done on the delegation by two non-government members,

VEBUD and VEBBS, Bob Eldridge, both old hands at international radio conferences.

...The removal of duty on Amateur transmitters and transceivers recommended by the Tariff Board last year can only become effective if it appears as an item in the forthcoming federal government budget. Since this is now under consideration and with a new Minister of Finance in power, Amateur organizations and individuals are urged to write immediately to bring the recommendation to his attention. CARF has already writter to the Minister but needs your support. Write now to Hon. Alan J. MacEachen, Minister of Finance, Ottawa, KIA OG8.

...The FCC is proposing to allow U.S. Amateurs on SSTV and facsimile on all frequencies above 3775. The U.S. Amateur population is now 372,958 and includes 3,815 clubs.

To - The Presidents of All Amateur Radio Clubs in Canada,

Now that we have a new Government it is strongly recommended that you write Alan J. MacEachen, Minister of Finance, Ottawa, KiA OG5, reminding him that on August 28, 1979, the Tariff Board recommended the removal of the duty on transmitters, receivers and transculvers designed for use only on Amateur Radio Frequencies and requesting that he implement that recommendation in the forthcoming budget.

You can justify your recommendation by pointing out the numerous benefits to Canada of Amateur Radio such as providing emergency communications, a source of skilled communications personnel, the development of new communications techniques such as packet radio and Amateur satellite communications. The loss of revenue would not be great as there are only about 20,000 Radio Amateurs in Canada and the removal of the duty would reduce the costs of equipment to Amateurs, encourage more to take up the hobby and increase the skills of Canadians in this area of communications and electronics.

As elimination of the duty must be a part of the budget and since this is now being prepared, your letter should be sent as soon as possible.

The Xmas contest was pather a bust, and another attempt will be made this year under the name 'Canada Contest', with rules the same as the CDC.

Classes: Single operator, all bands only. This contest is open to all, but non-members of CLARA may only work YLs.

Exchange: RS(T), name and QTH. Scoring: 1 pt/QSO, 3 pt/QSO with a bonus station. Bonus stations will identify themselves as such. Multiplier is the number of provinces and territories worked. A province or territory is counted only once for multiplier credit, regardless of band.

Entries: Must be postmarked not later than Dec. 31, 1980 and sent to Diana VanderZande VE7 DTO, SS#3, Jensen Rd., Prince George, B.C., V2N 2S7.

CARTG RTTY DX SWEEPSTAKES

Classes: Single op, single band; single op all band; multi/single; multi/multi.

Exchange: RST plus Zone. Scoring: for Canadians: 0 pt. per QSO with Canada, 2 pt per QSO with other North Americans. 3 pt per QSO with others. Multiplier is number of DXCC countries and CQ Zones worked on each of the bands added together.

All Canadian (Inner) Space Station

When the possibility arose of launching an Amateur radio experiment on a National Research Council balloon, the Canadian Amateur Radio Research Club was born, as the Council could not negotiate with individual Amateurs.

The first result was the flight of the 'Skyhook' operation in July last year when a 2-metre 'simplex repeater' was launched on a balloon from Gimli, Manitoba and rose to an altitude of 102,000 ft.

Initial membership was small but the members were farseeing and had high ambitions. Here was an opportunity for Canadian Amateurs to have access to facilities, equipment and expertise seldom available to our fraterrity. Now Canadian Amateurs could launch into the space age.

Following the success of the Skyhook flight, membership has increased and plans are being discussed for future experiments and projects. Although not all members would consider themselves to be experimenters in the normally accepted sense, all are keen to be involved in future projects, and each can play his part however humble.

The Club invites applications for membership from all Amateurs and will consider any suggestions for future projects and experiments. After listening to some of the ideas being kicked around at a recent meeting, it seems that no project would be considered "too far out"!

Among future projects in hand, or being discussed, are the development of a balloon package in which an RCA 1802 C.P.U. will be remotely programmed to perform various onboard physical functions, and a scheme to install UHF links between three Manitoba repeaters to provide what can only be described as dramatic coverage.

'CQ Magazine' generally presents the awards for its contests at this affair, and Sauli received the plaque from retiring CARF secretary John Gilbert VE3CXL, who was in attendance.

CARF also issues plaques for the top Canadian single-op, single-band entry in CQ's WW CW contest and, starting this year, the Federation will sward plaques for the top ASCII scores both worldwide and from Canadian stations in the Canadian Amateur Radio Teletype Group (CARTG) RTTY Sweepstakes.

CARF Annual Meeting

The CARF Board of Directors met in Citawa on May 30, 31 and June 1 and re-elected Bill Wilson VE3NR President of the Federation for another term. Don Slater VE3BID was elected Vice President. Lorna Hill VE3IWH, Don Emmerson VE3KJW and Art

Blick VE3AHU accepted the posts of Treasurer, Secretary and General Manager respectively.

At the meeting, the Board approved the hiring of secretarial help at the Kingston office, and issued a CARF life membership plus publicity in TCA to AMSAT Canada.

Full details on the meeting wil. be given in the October issue. To whet your appetite, here are two committee reports that were presented at the meeting.

CARF-DOC Liaison/Regulations

During the past 12 months, the CARF Radio Regulations Hancbook has been rewritten and expanded. Two amendments, necessitated by revisions to the General Radio Regulations Part II have been prepared for printing. The second of these amendments covers the extensive revisions made to the 'Amateur Service' part of the Regulations as a step in the de-regulation and codification program being undertaken by the DOC.

Direct liaison has been established with the Wireless Institute of Australia, Queensland Branch, through personal contact with the president (VK4QA) during a visit to Australia and his subsequent visit to Canada. Many subjects of mutual interest and concern to Amateurs, including operator qualifications and examinations. recognition by and membership in the IARU, Third Party Traffic Agreements, were discussed and publications were exchanged.

The exchange of publications with the Regio Society of Great Britain was accomplished as a result of 20m contacts and correspondence with G2ABC.

As a result of concern expressed by the Executive relative to the unprecedented growth of illegal operations adjacent to and within Amateur hands (particularly 10 metres), countermeasures are being instituted. Plans are underway

for the organization of a reporting system by Canadian Amateurs of illegal operations noted both within and without Amateur bands. If sufficient support is received, the reports will be summarized and submitted to the DOC for decisive action.

The 'Canada Gazette' is

regularly perused for announcements of interest to Canadian Anateurs.

Continued personal liaison is maintained with appropriate officers at DOC Headquarters on matters relating to Amateur activities.

Radio News Service

CARF Radio News Bulletins have been sent on a regular basis since the beginning of January 1979, starting with VE3TCA only. It is now being sent by a network of about 20 stations across the country. At present, bulletins are transmitted by phone, CW and both Murray and ASCII RTTY on 80, 40, 20, 10 and 2 metres.

Radio News Bulletins are produced weekly, and are mailed from VE3TCA in Ottawa to the News stations. Stations are encouraged to copy the transmissions from VE3TCA, when possible, for later retransmission. This reduces the number of mailings required, and ensures that the news is distributed as quickly as possible.

The response to these bulletins has been favorable, and in the case of the news of the proposed expansion of the U.S. 20 metre phone band, the response was overwhelming. That particular instance dem-

onstrated to many Amateurs the usefulness of CARF and its Radio News Service.

We would like to see the bulletins transmitted on more of the local and regional nets, where the present coverage is incomplete. To our knowledge, coverage appears to be least complete in the Preirie provinces and the Maritimes. Consultation is presently going on with stations in these areas, who may transmit news bulletins in the future.

The News Service will descontinue its regular schedule during the months of July and August, due to the generally decreased radio activity and the lack of worthwhile news. However, special bulletins will be transmitted at the regular times when the need arises.

The future should see an increase in the number of local two metre and HF bulletin stations.

June exam analysis

The June exam results were disappointing compared with some of the previous ones. Of the 492 who wrote the Amateur ticket, only 80 got their certificates; which works out to a mere 16%. It should be remembered though that many of those writing only tried one or two parts of the three-part tests. On the theory part, out of 436 who wrote it, 159 or 36% passed. Out of 322 who wrote the regulations, 215 or 67% made it. Two hundred and twenty-seven tried the morse but only 79 or 35% passed.

Only 49 (22%) out of 219 who wrote all or part of the Advanced diploma tests were issued their certificates. 76 out of 203 (37%) passed the theory, 115 out of 144 (80%) made the regs portion, but only 47 out of 138 (44%) read the morse test okay.

The digital licence picture was better... 100% of those writing passed.. that is, three out of the three who wrote the test. (Incidentally, U.S. sources quoting 300 digital operators to date are a bit wide of the mark... it's more like 100.)

South of the border the exampicture is different... but for somewhat suspect reasons. The steady climb in the success rate which brought an increase of 1.800 new licences in June alone and brought the total to 385.625 was almost equal to the number

issued in eight months of 1979. It can only be attributed to the open sale of exact exam questions sold as 'study materials', according to HR Report. That publication notes that "there is considerable feeling that the increased pass rates are due to memorization rather

than understanding, which would result in unqualified applicants receiving licenses and the license itself being cheapened as a result". "The FCC's rules." i: continues, "apparently have no provisions for protecting the security of its examinations."

Actually, what is really needed is a CARFCOM Manager who is in the central part of the country. Are you interested in local nets? This may be a challenging job for you.



DOC Update

Reciprocal licensing agreements were concluded between Canada and Hauti during the summer. There is not yet a third-party traffic agreement with Haiti. Canadian amateurs may handle third-party traffic from amateur stations in Bolivia, Chile, Colombia, Costa Rica, Dominica, El Salvador, Guatemala, Guyana, Honduras, Israel, Jamaica, Mexico, Nicaragua, Peru, Trinidad and Tobago, United States (including all territories and possessions), Uraguay and Venezuela. Canadian amateurs may not communicate with anateur stations in Iraq, Kampuchea (with the exception of XUIAA), Lubya, Somolia, Turkey, Viet Nam and the Peoples' Democratic Republic of Yemen(70A-70Z).

"Dear Sir: We have received an enquiry from the Canadian Radio Relay League concerning the possibility of Canada and Australia entering into a special arrangement..." This letter, dated 1980 June 12, and signed by W.W.Scott on behalf of Ir. John deMercado, Director-General of Telecommunications Regulatory Service, seeks a third-party traffic agreement between Canada and Australia. A simple letter of concurrence from the Australian authorities would put the agreement into effect. Keep your fingers crossed!

R. F. Stevens, G2BVN, Secretary of IARU Region 1, has written a letter to Dr. John deMercado, Director-general of Telecommunications Regulatory Service, asking DOC to reconsider its position concerning conditions recently imposed on reciprocal licensing. Under these conditions, a foreign amateur may operate on a particular mode and frequency only if that mode and frequency is allowed by both Canadian regulations and the regulations of the foreign amateur's home country. One effect of these conditions is to keep visiting European amateurs off our two meter repeaters. In Region 1, amateurs are only permitted to operate between 144 and 146 EHz, and most if not all of our repeaters are between 146 and 143 MHz. CRRL supports G2BVN's request, and is also petitioning DOC on the matter.

Canadian Amateur Satellite Project Moves Ahead

The failure of the Arienne III launch vehicle and the demise of the first Phase III amateur satellite brought disappointment to thousands of anatours around the world. Despite this setback, there are still many reasons to be hopeful. The Phase III satellite which went down on May 23 was by no means the only amateur satellite project under way.

Since 1978, a dozen or so amateurs in the Ottawa area, members of the Radio "Amateur Satellite Association, Canada, generally known as AMSAT-CANADA, have been developing a Phase III-type satellite package of their own. As with other Phase III packages, the design is for high orbit and long life. Members of AMSAT-CANADA have been working only on the transponder, the antennas and the control circuitry. Unlike the Phase III satellite that recently went down, the Canadian satellite package is not designed to become a totally independent unit. It will remain "on the bus", that is, on the final stage of the launch vehicle, and share a power collection, storage and distribution system with a number of commercial units mounted on the same rigid frame. This new configuration marks the end of "backyard satellite building". A malfunction in the amateur package could adversely affect the operation of the commercial units, and the Canadian amateur satellite package is being designed and built to the strictest commercial standards.

Mode M, the primary mode of the Canadian satellite package, will take advantage of the frequency allocations made at WARC '79. There will be a 1261.6 MHz uplink and a 435.6 MHz downlink. Such frequencies might frighten amateurs whose VHF-UHF experience ends with 2 meter repeater operation, but they offer many advantages. Ground station requirements become reasonable. 10 watts of RF fed to a simple antenna mounted over a 4 foot dish will easily access the package's transponder. The same dish can supply gain needed for the receive antenna. The particular relationship between these uplink and downlink frequencies, and the small amount of Doppler shift expected with the geostationary or near-geostationary orbit, will make transceive operation viable and net operation easy. The minimum bandwidth of 100 kHz and perhaps 200 or 300 kHz, and the projected height of over 10,000 km, will make the Canadian satellite package accessible to hundreds of amateurs, in over one-third of the world, at a given time.

How soon might the Canadian satellite package be placed into orbit? The project has been slowed down, due to difficulty in obtaining parts which will maintain their tolerences in the harsh space environment. Conventional components degrade quickly when constantly bombarded by minute solar particles. AMSAT-CANADA President John Henry, VE2VQ, who also sits on the AMSAT board in Washington as an AMSAT director, estimates that everything necessary could be assembled, tested, and made ready for a launch within a year and one-half. He also adds that the Canadian satellite package, as a whole, might never be placed into orbit. Instead, parts of the package, such as the transponder IF strip, or some of the control circuitry, might be incorporated into one or other AMSAT project.

Whatever happens, however, Canadian amateurs can be proud that some of their number are making significant contributions to the amateur space program.

Any Canadian anatour may hold a League Emergency to-ordinator appointment. For years, only Advanced Amateur certificate holders held such appointments in Canada. Larry Thivierge, VE3GT, the Ontario SCM, wrote to John Lindholm, VIXX, the League's Communication Department Nanager, and found that the minimum licence required for an EC appointment in the U.S. was Technician. John commented, "Since the Canadian Amateur certificate gives far greater privaleges than the U.S. Technician certificate, such a certificate would certainly qualify one to hold an EC appointment", and advised Larry, and other Canadian SCMs to "...feel free to make such appointments."

Former President Ron Hesler's duties have now been delegated. Oftawa liason is being maintained by Ray Perrin, VE3FN, 47 Cymboline Drive, Ottawa, Ontario K2B 7X9. IARU representation is being handled by Tom Atkins, VE3CDM, 55 Havenbrook Boulevard, Willowdale, Ontario M2J 1A7. Tom will be attending the IARU Region 2 mosting at Lima, Peru in October.


AMSAT and Canade's Digipeter group have been discussing digital communication techniques, and how they might apply to amateur satellite projects.
